Intraco Limited (the "Company") announced on 22 June 2023 that the Company has launched a S\$50 million multicurrency, unsecured and unsubordinated commercial paper facility programme (the "SDAX CP Facility Programme") on a recognised licenced digital platform in Singapore operated by SDAX Exchange Pte. Ltd.

In connection with the above, the IL_D031_1A/SGD and IL_D024_1/USD, which was launched on 14 Aug 2026, under the SDAX CP Facility Programme, had matured on 17 Sep 2026.

Accordingly, the 40 Tokens (direct and deemed interest) in respect of the IL_D031_1A/SGD and IL_D024_1/USD issued on 14 Aug 2026 have been fully redeemed by the Company on 17 Sep 2026.
